#### I. CALL TO ORDER/PLEDGE OF ALLEGIANCE

Board President Frohbieter called the meeting to order at 7:00pm.

#### II. ROLL CALL

Members present: Mr. Eckelberry, Mr. Frohbieter, Mr. Hanks, and Mrs. Lee. Mr. Holmes absence is excused.

#### III. APPROVAL OF AGENDA-Mr. Frohbieter recommended adding Discussion Items B-D which is the Open House on November 2, moving the November Board Meeting to November 21<sup>st</sup>, adding a Work Session on December 6<sup>th</sup> for the audit and a proposal from Brian and Tim regarding personnel. A motion to approve the Agenda as revised was made by Mr. Eckelberry. Mr. Hanks seconded the motion. All Board Members present voted "aye". The motion passed.

#### IV. APPROVAL OF MINUTES- Mr. Eckelberry made the motion to approve the minutes from the September Board Meeting. Mrs. Lee seconded the motion. All Board Members present voted "aye". The motion passed.

#### SUPERINTENDENT'S REPORT-

Our Open House for the National Training Center is scheduled for 6pm on November 2<sup>nd</sup>. We've invited over 500 Businesses, Companies and Partners to share with us. Mayor Suthers, State Rep Paul Lundeen and Mark Waller have all responded that they will be there. Come a little early and please wear your Peyton gear. We are very amazed and pleased with the response with the partnerships and donations that have come our way. You have received the list of equipment; we are now starting to track the financial donations. JLT Clamps has promised significant financial support. We also have received great response from our local contractors, electricians, architects and engineers as to how they would like to help us with our building. Dean and I are speaking to the El Paso Contractors on Nov 1<sup>st</sup> to see what they can do to help. Our October count is nearly spot on with our projections. Elementary population is up a little and our Online Academy has 12 students. We are scheduling our Out of District visits for our CTE Programs. Right now, we have Widefield and Falcon coming on December 2<sup>nd</sup> and January 13<sup>th</sup>. The other Rural Schools will be invited to those dates as well. Currently, I am talking to D20 and D11 to see if they are interested. The District was able to purchase some movie tickets and the different buildings were able to have a drawing. This included the maintenance, custodial, cafeteria and transportation staff. This is in response to the staff survey that we show our appreciation for all the hard work that they do throughout the school year.

**IX. A. Quarterly Financial Report-**Mrs. Kirchner presented the Board with the Quarterly Financial Report for September 30, 2016. She reminded them that the numbers reflect unaudited figures and do not represent any changes in student enrollment for the 2016-2017 school year. The District will need to revise its Budget for the year in January for the Capital Reserve Fund to reflect the Insurance Proceeds and Expenditures for the wind damage at the Stadium and some water damage at the CTEF Building. Tim revenues have not been received from other districts. BEST Grant requirements-is that something that we should consider. A motion to approve the Quarterly Financial Report was made by Mrs. Lee and seconded by Mr. Eckelberry. All members present voted "aye". The motion passed.

**B. Recommendation to revoke the charter of The Career Building Academy for material violations of the conditions, standards, or procedures set forth in the contract between the District and the Charter School.-**Mr. Frohbieter sited Article 12.4 of the Contract between the Peyton School District Board of Education and The Career Building Academy. The Board needed to determine a termination date and give the date to TCBA . He proposed November 16<sup>th</sup> at 7pm for the Hearing Date and Time. The Board is requirement to give them 2 weeks' notice. Mr. Frohbieter made motion to set the hearing date and time of November 16<sup>th</sup> at 7pm Mr. Eckelberry seconded the motion. All Board Members present voted "aye". The motion passed.
