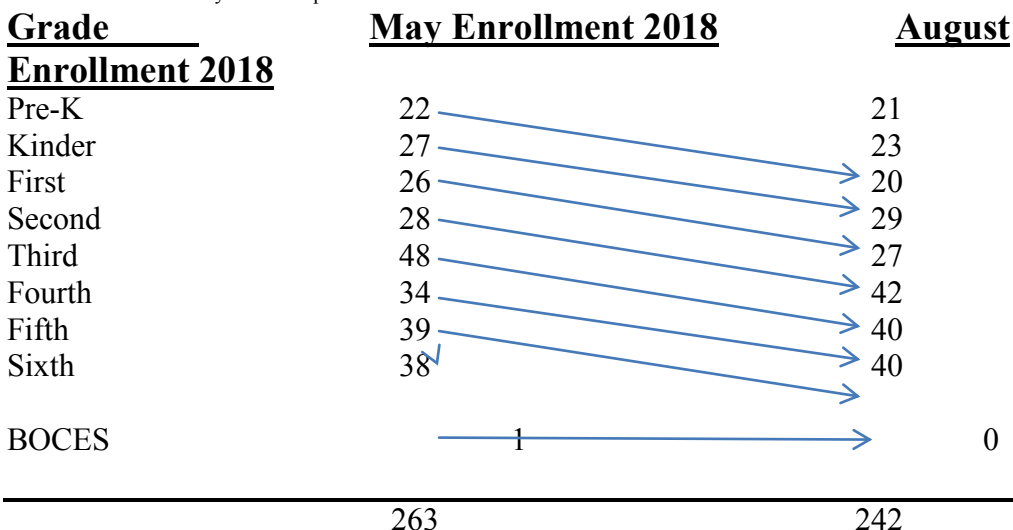


# RECORD OF PROCEEDINGS

## PEYTON SCHOOL DISTRICT 23-JT Board of Education Minutes August 17, 2018 7:00pm Peyton Elementary School

- I. CALL TO ORDER/PLEDGE OF ALLEGIANCE**  
Board President Frohbieter called the meeting to order at 7:01pm.
- II. ROLL CALL**  
Members present: Mr. Eckelberry, Mr. Frohbieter, Mr. Hanks, Mrs. Lee and Mrs. Mannering.
- III. APPROVAL OF AGENDA-** Mr. Eckelberry made the motion to approve the Agenda. Mrs. Lee seconded the motion. All Board Members present voted “aye”. The motion passed.
- IV. APPROVAL OF MINUTES-** A motion to approve the Minutes was made by Mr. Eckelberry and Mrs. Mannering seconded the motion. All Board Members present voted “aye”.
- V. APPROVAL OF FINANCIAL ITEMS-** Mr. Eckelberry had one question on the Accounts Payable Register regarding payment for lighting and if it was covered by insurance. Mr. Land explained that because of the deductible on the insurance it was not worth filing. The charges for the press box include removing old siding, paint & trim. The man lift rental was \$1500. Thank you Mr. Hanks for all your and Chet Miller’s volunteer hours to update the press box. Mr. Eckelberry made the motion to approve the Financial Items and Mr. Hanks seconded the motion. All Board Members present voted “aye”.

Mr. Bates addressed the Board regarding his concerns regarding Armed Staff. Jennifer Keith also sent a Survey Monkey that included open ended questions. She has received 29 responses thus far. The Board stated having the Survey Monkey with names would be better, so they can address the pros and cons referenced in the survey.

  - A. Parent/Staff Survey Results-The district emailed out a Survey Monkey to parents of students and staff. They received 148 responses, 77% were in favor of armed staff.

- We have 11 new out of district students, 45 new in district students Pre K – Sixth grade (19 are Pre-K and 26 are kindergarten-6<sup>th</sup> grade students), and 34 students moved. Most of the students that withdrew moved out of state. We also had some foster kids that had a different placement.
- We had a fire drill on August 16<sup>th</sup>.
- Back to School Night was well attended.
- We are finished with beginning of year DIBELS testing and will finish NWEA/MAP testing this week.
- Mrs. Hoelscher was recognized on August 11<sup>th</sup> as the Junior Achievement Educator of the Year in Southern Colorado. Her Junior Achievement Volunteer, Dave Zirkle was recognized as Volunteer of the Year and will be back at PES for the 2018-2019 school year.



- CMAS scores were released and we were pleased with academic achievement, as well as academic growth again this year.

On the staff work day August 7th, all instructional staff received training on the new curriculum Peyton Jr.-Sr. High School received through a Social-Emotional, and Career and College Readiness grant from the Generation Schools Network. This curriculum will be implemented during Advocacy period, which is the last twenty minutes of the day. Each group is approximately 15 students and grouped according to grade level. The curriculum provides executive functioning skills to students, as well as allows teachers the opportunity to help students monitor grades, and give extra support where needed.

Back to school night was held on Tuesday August 7th, we had great attendance, and the Peyton Panthers Booster Club provided dinner to staff and families, as well as sold dinner to the families in attendance.

School is off to a great start, student schedules are set, with today being the last day for students to request changes.

On the first day of school Peyton Jr.-Sr. High School held a Welcome Back Assembly for all grade levels, each student received a Peyton Way bracelet, and signed their classes Commitment to Graduate Banner. The banners will hang in the cafeteria.

NWEA testing is taking place right now, and will be completed within the next week. CMAS, PSAT, and SAT scores were released last week. Peyton Jr.-Sr. High School showed an increase on both achievement and growth. A breakdown of the data will be provided in the next week.

On 8/22, the third annual Senior Sunrise will be held on the practice field behind the high school. The Senior class will take their picture at sunrise, close to 6:00 am, dine on doughnuts and then head to class. The Senior Sunset picture will be held in May.

On Wednesday 8/29, Peyton Jr.-Sr. High School staff will be trained on RANDA, the state evaluation system. This orientation is a required part of the evaluation process.
