## PEYTON SCHOOL DISTRICT 23-JT Board of Education Minutes March 19, 2019 7:00pm Community Room at the CTEF Building

- I. **CALL TO ORDER/PLEDGE OF ALLEGIANCE**  
Board President Frohbieter called the meeting to order at 7:02pm.
- II. **ROLL CALL**  
Members present: Mr. Eckelberry, Mr. Frohbieter, Mr. Hanks, Mrs. Lee and Mrs. Mannering.
- III. **APPROVAL OF AGENDA**-Mr. Frohbieter recommended the Action Item B be moved to Discussion Items per Mr. Land's request. Mr. Frohbieter requested the addition of Item C under Discussion to reschedule the Board Retreat from March 23<sup>rd</sup> to April 6<sup>th</sup>. Mr. Eckelberry made the motion to approve the Agenda as revised. Mrs. Mannering seconded the motion. All Board Members present voted "aye". The motion passed.

**X. DISCUSSION ITEMS**

- A. **Discussion of LED Light Replacements**-Mr. Land talked to the Board a couple of years ago about the LED light replacements. He has not been able to review the final bid, so he would like to discuss the item tonight and add to Action Item for April meeting. Excel energy updated a portion of the Community Room to show what the LED lights will look like. They are drop-in sealed units and energy efficient. They will eliminate migraine complaints based on lighting. The energy savings will pay the lease agreement. The bulbs will last 10 years. The return on investment is 6.5 years with a 10 year warranty. The district can go through Farmers' State Bank for a 3.5% loan.
- B. **Reschedule Board Retreat to Saturday, April 6<sup>th</sup>**-(From March 23<sup>rd</sup>) since Mr. Kistler out of town, the Retreat needs to be rescheduled.
